ONE:

The name of this corporation is: RETIRED EMPLOYEES OF MERCED COUNTY ASSOCIATION, INC. The name of the existing unincorporated association now being incorporated by the filing of these Articles is: RETIRED EMPLOYEES OF MERCED COUNTY.

TWO:

- (a) This corporation is a nonprofit mutual benefit corporation organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity, other than credit union business, for which a corporation may be organized under such law.
- (b) The purposes for which this corporation is formed are pleasure, recreation, and other nonprofit purposes, and specifically as a social club, within the meaning of Internal Revenue Code §501(c)(7), or the corresponding provision of any future United States Internal Revenue law, to advocate, educate, inform, and provide activities for retired former employees of the County of Merced and of other governmental entities in the greater Merced County area of California.
- (c) Despite any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that do not further the purposes of this corporation, and this corporation shall not carry on any other activities not permitted to be carried on by (i) a corporation exempt from federal income tax under Internal Revenue Code section 501(c)(7) (or the corresponding provision of any future United States internal revenue law), or (ii) a corporation, contributions to which are deductible under Internal Revenue Code section 170(c)(2) (or the corresponding provision of any future United States internal revenue law).
