ARTICLE III. MEMBERS

SECTION 1. ACTIVE MEMBERSHIP.

Active membership ("Active Members") in the corporation is available to:

- a. Any person retired from employment by the County of Merced and those special Districts who are members of the Merced County Retirement Association ("MCERA"), who receives retired allowances under the Retired Employees Retirement law of 1937; or
- b. Any person who is a surviving spouse or a designated beneficiary of such employee receiving retirement benefits from MCERA.

SECTION 6. GOOD STANDING.

Members who have paid the required dues, fees, and assessments in accordance with these Bylaws and who are not suspended shall be members in good standing.

 The Directors of the corporation shall be residents of the State of California. Each Director shall be an Active Member of the corporation in good standing.

Petition to Replace Merced Community Activity Centers That Will Soon Be Lost

We, the undersigned residents of Merced County, California hereby petition City Council for the replacement of the Merced Senior Community Center and the McCombs Youth Center that will soon both be lost due to acquisition by the California High-Speed Rail Authority Project.

Funds obtained from the California High-Speed Rail Authority for the impending sale of these city-owned properties by 2025/26 should be entirely dedicated to the immediate development of a new Merced Senior Activities Center and a new McCombs Youth Center, or dedicate all the funds to a combined Multigenerational Activities Center, in a new, centrally located, easily accessible, and safe area of our city.

For nearly three decades, the Merced Senior Community Center has been a vital hub, hosting a wide array of activities including mat and chair yoga, line dance, belly dance, ballroom dance, wood carving, crafting, readers theater, a writer's group, dominos, Pinochle, Bridge, Mahjong, Senior Social & Bingo gatherings, AARP meetings, and numerous weekend community events such as weddings and receptions, baby showers and birthday parties, fundraising events and community breakfasts with Santa. Additionally, our center has served essential community functions such as hosting the annual Tax Aide program, Highway Patrol Award Ceremonies, City Employees Annual Recognition lunch, acting as a 2023 flood emergency supply distribution center, and accommodating jury selection overflow for the courts during the pandemic.

The nonprofit organization Merced Senior Citizens Inc. fundraised a significant portion of the current building's construction cost, underscoring the community's commitment and investment in this important resource which led to a unique building use agreement with the city. Given this history of support and the pressing need for a new facility, we strongly believe that dedicating High-Speed Rail funds towards a new Merced Senior Activities Center and a McCombs Youth Center, or a Multigenerational Activities Center, aligns perfectly with our community's objectives and promotes the mental, physical, and social well-being of our residents for generations to come.

We urge our elected officials and city decision-makers to prioritize the needs of our community and act swiftly to mitigate the loss caused by the High-Speed Rail acquisition. Together, let's preserve and enhance the quality of life in our community by reinstating our beloved activities centers.
