WHAT IS REMCO:

REMCO is our local organization of over 1300 members who have retired from Merced County employment. Dues are \$3 per month, withheld from pension checks. REMCO membership is optional for retirees but is required to participate in the supplemental benefits provided through Pacific Group Agencies, receive discounts on quarterly luncheon meetings, receive the quarterly newsletter, and receive other benefits of the organization. REMCO membership also includes membership in CRCEA (see below).

WHAT IS CRCEA:

CRCEA is an association of the 20 California counties (including Merced County), whose retirement systems are governed by the County Employees Retirement Law of 1937 (referred to as 1937 Act Counties). CRCEA has a combined membership of over 180,000. Member counties benefit from a paid lobbyist in the state legislature, and a legislative analyst who is also a CRCEA board member. This connection with the state legislature allows CRCEA to take immediate action regarding any legislation which is deemed to be either beneficial or harmful in nature. REMCO membership includes membership in CRCEA. CRCEA holds two conferences each year, one in the spring and one in the fall. REMCO is represented at these conferences by delegates from each member county. The representatives for REMCO are Jackie Walther-Parnell, primary, and Scott Johnston, alternate.

NEW BOARD MEMBERS:

No nominations were received for new directors, so a further notice was put out. There were six volunteers who responded and were considered by the Board at their October meeting. It was determined by the Board to accept the first four volunteers to fill the four empty director positions. Remaining volunteers have been added to a list for future openings. New COVID-19 Boosters that target multiple strains are now available: The new COVID-19 bivalent boosters have arrived in Merced County. The new bivalent boosters were developed to generate an immune response from the original COVID-19 virus as well as the BA-4 and BA-5 Omicron subvariants. Supplies may be limited and are currently available across the region at vaccination locations, including pharmacies and medical providers.
